The Warrant List was reviewed. Trustee Glueck made a motion for approval with Trustee Alig seconding. With a vote of 6 yeas and 0 nays, the motion passed.

Don Hutchens, 520 W Michigan, addressed the Board regarding the location of the new firehouse. He suggested other places but was informed the location had already been agreed upon.

## **Mayor's Report**

Mayor Cummings informed everyone he would not be attending the next meeting so Interim President Nauman will be in charge.

Mayor Cummings presented the 2022 Tax Levy Ordinance and asked for a motion for approval. Trustee Weyeneth made that motion with Trustee Alig seconding. With a vote of 6 yeas and 0 nays, the motion passed.

The Mayor then presented the Ordinance for Annexation of the Russell Property Off Santa Fe Trail and asked for a motion for approval. Trustee Schierer made that motion with Trustee Bowers seconding. With a vote of 6 yeas and 0 nays, the motion passed.

## **Public Works Dept.**

Trustee Nauman made a motion to approve the purchase of a Block of 24 Hours from Cloud Point for GIS in the amount of \$4200.00. Trustee Alig seconded and with a vote of 6 yeas and 0 nays, the motion passed.

Trustee Nauman asked for a discussion of Christmas bonuses for employees. It was decided to give full time employees \$300.00 and part time employees \$200.00. Trustee Schierer made a motion for approval with Trustee Bowers seconding. With a vote of 6 yeas and 0 nays, the motion passed.

#### Police/Fire/ESD

Trustee Schierer made a motion to approve the purchase of a battery-operated Jaws of Life for the Fire Dept. in the amount NTE \$7700.00. The full purchase price is \$23,000.00, but the cost is to be split between the Village, MFD and the Rural Fire Dept. Trustee Glueck seconded the motion and with a vote of 6 yeas and 0 nays, the motion passed.

Trustee Bowers made a motion to approve the purchase of 8 body cameras on a 5-year contract @ \$11305.18 per year beginning Jan. 2023. Trustee Weyeneth seconded the motion and with a vote of 6 yeas and 0 nays, the motion passed.

Trustee Schierer made a motion to approve the purchase of 4 in-car cameras on a 5-year contract @ \$9983.98 per year beginning Nov. 2023. Trustee Bowers seconded the motion and with a vote of 6 yeas and 0 nays, the motion passed.
